

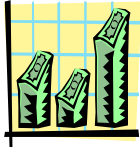
# TAXATION



The September quarter 2010 shows that Gross Turnover was \$149.6 million for all industries in the Cook Islands. This is an increase of 12.7% when compared to the previous quarter and a decrease of 2.3% when compared to the September quarter 2009.

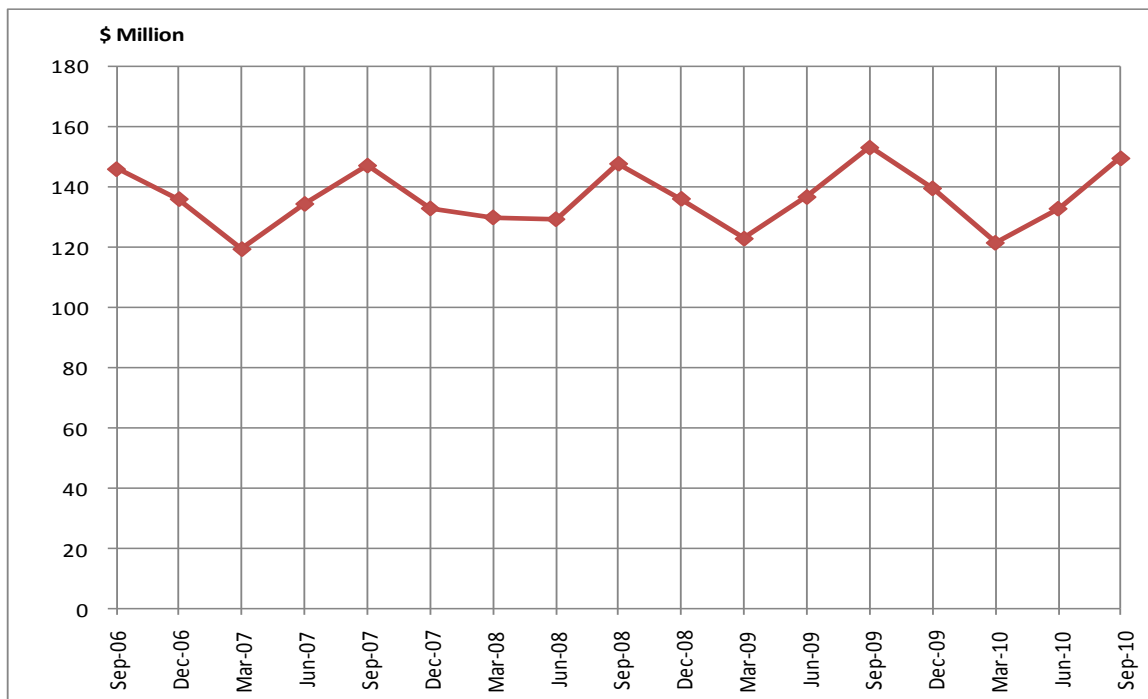


Total Value Added Tax (VAT) collected on Sales and Income was \$15.3 million for the Cook Islands in this quarter. The Wholesale & Retail Trade industry continued to contribute the highest VAT collected on Sales and Income with 35.6%, followed by Hotels & Motels with 17.7% whilst Transport & Communication and Finance & Business contributed 14.6%.



The graph below displays a fluctuating trend with Gross Turnover for the Cook Islands up to September quarter 2010, showing an increase over the June quarter 2010.
